PASSES NEVER EXPIRE. VALID ANY DAY UNTIL REDEEMED. The combination pass can be used over the course of two days (i.e. water park portion can be redeemed one day and the amusement ride portion can be redeemed any other day)

- The organization may resell each ticket at a price to be determined by the organization itself, but shall not exceed the 2015 general admission price.
- IMPORTANT: All fund raiser ticket orders must be submitted to Morey's Piers by April 29, 2016 along with the organizations valid NJST-5 (if applicable).
- *TAX IMPLICATIONS:

NJ Public schools are exempt from paying 7% NJ State Sales Tax as well as 2% Cape May County Tourism Tax. Payment must be made by a school-issued check.

Private and out-of-state schools WITH a NJST-5 form are exempt from paying 7% NJ State Sales Tax but are required to pay 2% Cape May County Tourism Tax on amusement and catering portion only. A valid, signed copy of your school's NJST-5 form must accompany the final order to be eligible for tax exemption. Payment must be made by a check issued from the account of the school named on the applicable NJST-5.

Private and out-of-state schools WITHOUT an applicable tax exempt certificate (NJST-5) are required to pay both 7% NJ State Sales Tax and 2% Cape May County Tourism Tax on amusement and catering portion only.

HOW MOREY'S PIERS FUND RAISER WORKS:

Your school determines the ticket prices for your fund raiser (not to exceed the general admission rates.) Fund raiser tickets are priced to allow schools to raise money while providing their community with a discount to the piers and water parks.

Each student will receive an order form. Please indicate how many order forms would you like on the form below. Once the sale is over, students return their order form and payments to the fund raiser coordinator at your school. Your fund raiser coordinator simply mails in the orders' summary along with a payment (ONE check made out by the fund raising organization).
